DUTIES: Operates a school bus and may perform minor maintenance tasks in connection with such operation. This is manual work of average difficulty requiring skill in the operation of a large automotive vehicle. The operator is responsible for the safety of the children transported. The operator maintains orderly conduct of students on the bus and may be required to sweep and maintain cleanliness of the bus interior; may be required to wash bus exterior and add gas and oil. May be required to maintain daily work sheet or related records. Performs related work as required.
